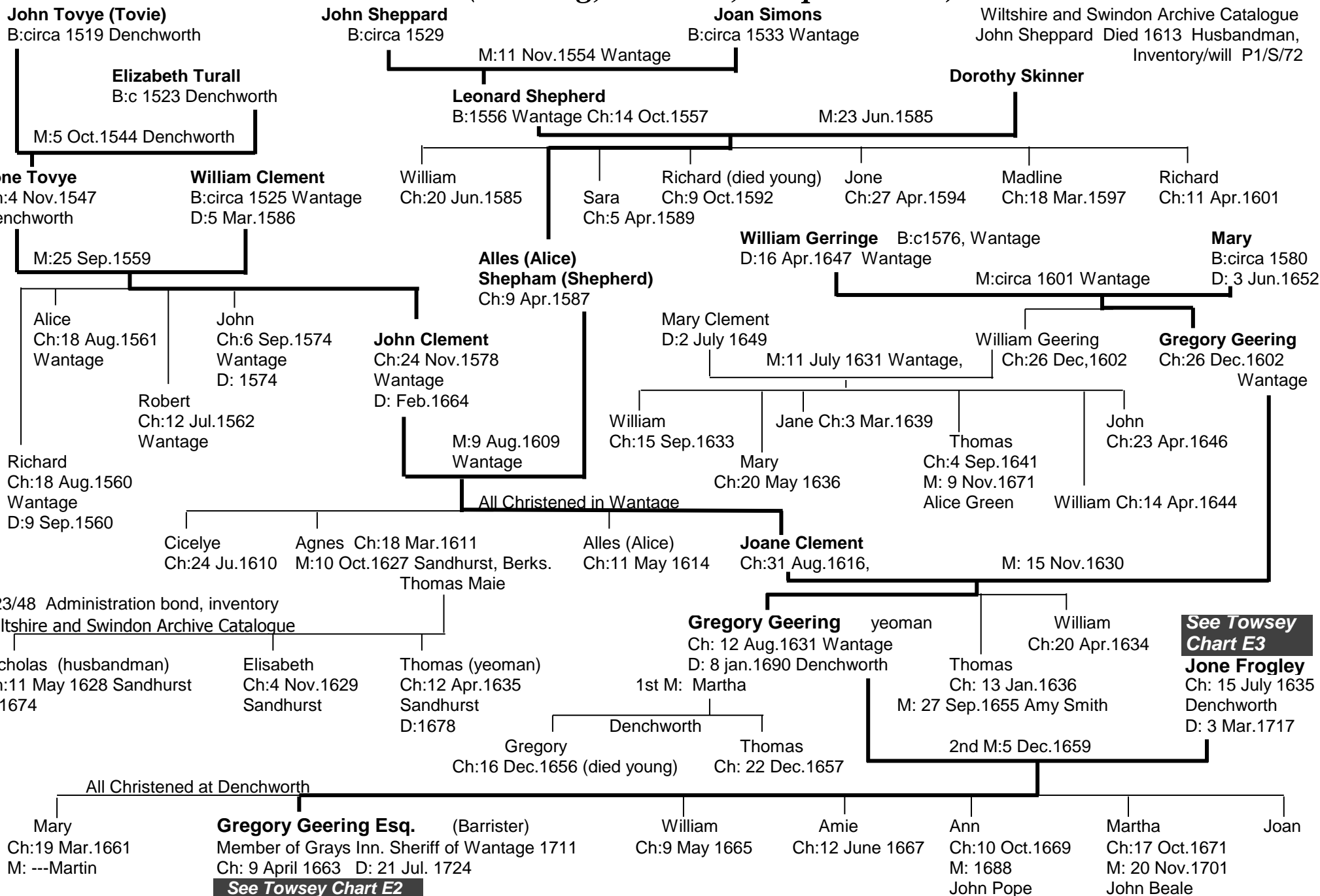
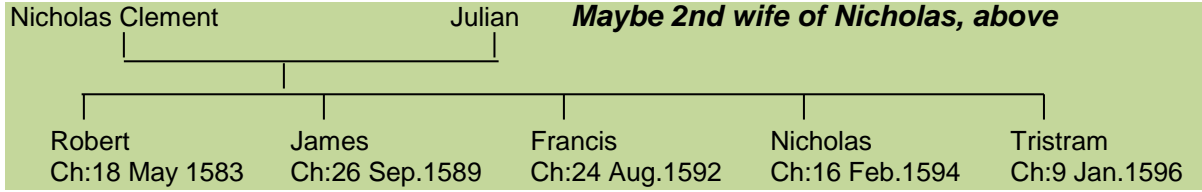
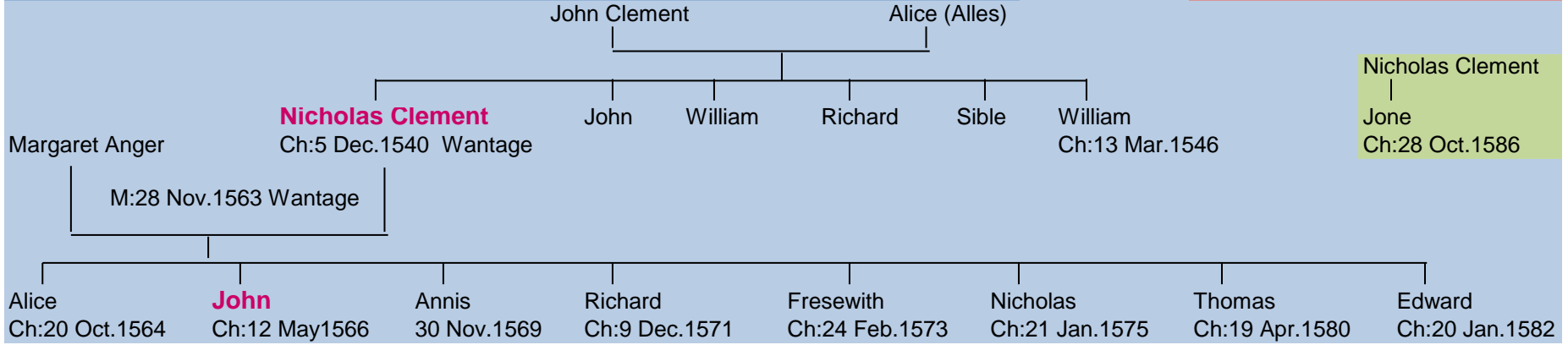
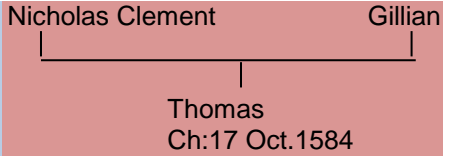


TOWSEY CHART E6 (Geering, Clement, Shepherd etc.)

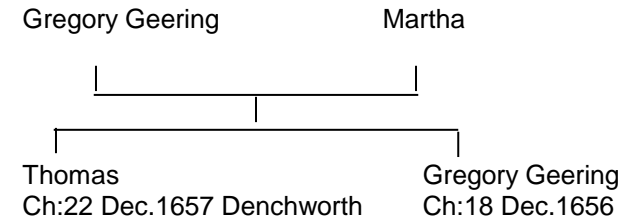

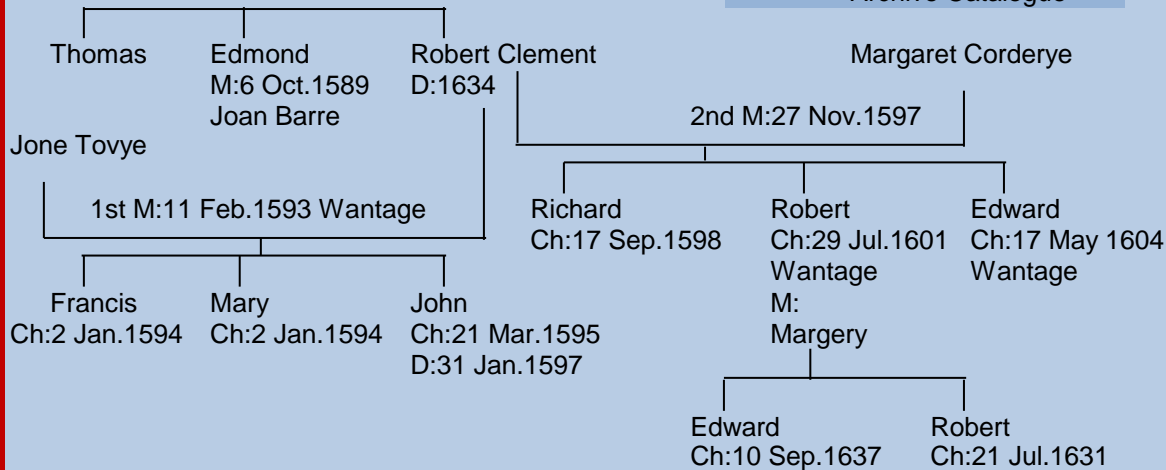
